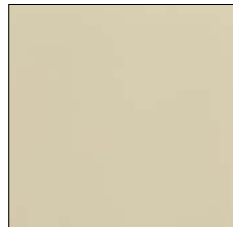
COVER PROPERTIES

Rancho is a corrected grain, embossed and coated leather. Since leather is a natural product, the individual characteristics of each hide are nevertheless visible, which is what makes each piece of leather upholstery unique. The back and arms are covered with a high-quality polyurethane synthetic leather with an irregular embossed finish. The PU finish has a natural-looking leather appearance, ranging from smooth to strongly textured. Synthetic leather is characterised by its durability, wear resistance and ease of cleaning. Wiping with a clean, damp cloth is generally all it takes to clean the leather. Do not use aggressive cleaning materials or care products containing grease, which may damage the surface. If in doubt, ask your retailer. Do not place your furniture immediately next to sources of heat (radiators, fireplaces) and avoid strong, direct sunlight. Avoid the transfer of colour from clothing or throw cushions. Variations in colour and texture are typical of this product and are no grounds for claims or complaints.

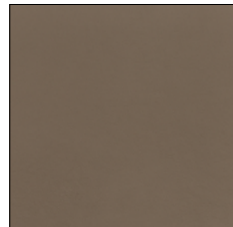

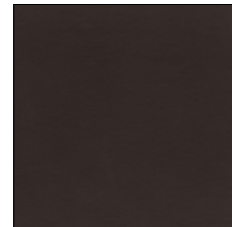
